The inspection team may visit the above college for the purpose and expedite its specific report within 10 days , positively, from the date of issuance of the office order.

The Incharge of the team is also requested to ensure before proceeding to visit the College that the other member(s) appointed by the University for the purpose may join him positively while visiting the college and all the members including him shall sign the report. The report not signed by all the members shall not be acceptable to the University.

The remuneration of Rs. 500/- per visit shall be permissible to the members of the team for conducting the inspection work of affiliated colleges vide Notification no. Acad.II/06/BOI/15089 dated-20.12.2006. Accordingly a blank T.A. Bill form is also enclosed herewith, which may kindly be sent duly completed for payment of your T.A. & D.A., along with the Report.
